This is a corrected notice of the 2019 Notice of Nomination and Election to ensure compliance with Local 1395 Constitutional requirement of advance notice of 15 days prior to the Nominating Meeting which has been rescheduled to September 11, 2019.

You are receiving this letter as a member of AFGE Local 1395. Honest Ballot, an independent election services company, will oversee the nominations and election proceedings for the AFGE Local 1395 2019 election of officers and delegates. This year, you will have the option to vote online, as well as by mail from October 10, 2019 through November 12, 2019. More information will be included in a voter information letter which you will receive prior to the election.

To be qualified as an officer or candidate for office, an individual must meet the following qualifications: (1) be a member in good standing in this local; (2) be a member for one year of an AFGE local; and (3) not be a member of any labor organization not affiliated with the AFL-CIO. Candidates shall not run for more than one office in the same local election. The term of office is three years ending with the installation of their successor.

Qualifications

To be a candidate, members must be nominated/self-nominated either at a designated membership meeting or by mail. The member making the nomination has the responsibility of informing the nominee of his or her nomination. **NOTE:** All previously submitted Nominations will be accepted.

Nominations

If you would like to submit a nomination, please review the following information. To be a candidate, members must be nominated either at a designated membership meeting (September 11, 2019) or by mail.

- The nominating member has the responsibility to inform the nominee of his or her nomination.
- Candidates have the responsibility to submit a copy of the enclosed Acceptance Statement.
- Candidates may accept nomination for **one (1) officer position only.** Candidates also accepting nomination for a delegate position must submit a separate Acceptance Statement for each nomination.

➤ At a Membership Meeting

Nominations will be accepted from the floor at the September 11, 2019 membership meeting at 6:00 P.M. at the **Harold Washington Program Service Center, Learning Center Conference Room 1, 600 W. Madison, Chicago, IL 60661. A nominee must accept or decline nomination if present at the nomination meeting. All nominees must sign an Acceptance Statement. Any nominee not present

must submit a written Acceptance Statement to Honest Ballot at 27246 Grand Central Parkway, Floral Park, NY 11005 on or before **5:00 P.M. on September 11, 2019.**

➤ **By Mail**

Nominations by mail will be accepted on the enclosed Nominations Form. Please submit a copy of the Nominations Form to nominate a qualified member for any of the offices listed below. You may use one form to nominate multiple people. Make additional copies of the form as needed. Be sure to include the candidate's name, position, phone number, and email address. Notify the candidate of his/her nomination.

Nominations by mail must be received by Honest Ballot, at 27246 Grand Central Parkway, Floral Park, NY 11005 on or before **5:00 P.M. on September 11, 2019.** **A business reply envelope is enclosed for your convenience to submit nominations forms.**

Union funds and resources of any type may not be used to support the candidacy of any person in a union officer election. This restriction applies to **facilities, equipment, supplies, labor,** as well as cash.
